REPORT FOR THE CAPTAINS FLAT COMMUNITY ASSOCIATION MEETING OF SEPTEMBER 20TH 2006:

Incidents:

- Search for missing hunter weekend before last.
- MVA yesterday Jerangle/Wild Cattle Flat Rd. No known serious injuries.
- Smoke sighting late Sunday afternoon, nothing found, probably Pryor's Pines.
- Pryor's Pines lit up last night due to high wind/dry conditions. 3 appliances (vehicles) attended with crews.

Training:

- Members successfully passed "Basic Firefighter", 2 and "Advanced Firefighter", 3.
- 2 new members joined up, yet to submit paperwork.

Hazard reduction:

• "El Capitaine", large area of poisoned broom burned last Sunday plus area behind houses, pub and club. Local Brigade assisted by neighbouring Stony Creek and Farringdon crews.

Bushfire risk to Captains Flat residents: Under the 1997 Rural Fires Act, NSW it is the properly owner's responsibility to prepare their property for the fire season. While conducting the HR on Sunday, I observed many houses in Foxlow Street that had large, dry tussocks and other fuel right up to their fences. This places them at risk in the eventuality of a fire. Captains Flat is in a bushfire prone area and we must become more conscious of the potential for property loss.

I am keen to meet with small groups of interested residents to work out how to best protect their assets. I will be putting some information in the Telegraph as well.
